Objectives and Programs of the Cox Foundation

Established in 1980 by Mrs. Una Chapman Cox of Corpus Christi, Texas, the Cox Foundation is dedicated to the proposition that the United States needs a strong, professional foreign service. It serves that objective through programs that enhance the recruitment, professionalism and effectiveness of the US Foreign Service, improve the well being and retention of its best employees and their families and increase public knowledge and understanding of the Foreign Service and its role in supporting US foreign policy and national security interests.

The Cox Foundation uses its resources to fund projects and activities within its area of interest, and to encourage support from other public and private institutions. Where appropriate, the Cox Foundation also contributes human resources and experience, derived from its ongoing relationships with active and retired Foreign Service Officers and the organizations to which they belong.

The Cox Foundation funds career enriching activities for Foreign Service Officers and their spouses which places them in contact with the general public, thus bolstering the Foundation's objective of increasing public awareness and understanding of the Foreign Service. Other Cox Foundation programs address particular concerns, inherent in service abroad, of Foreign Service spouses and family members.

Trustees and Policy Council

Overall direction of the Foundation rests with its five Trustees: they include a continuing Trustee who knew and worked with Mrs. Cox, a member of the Chapman family, and a rotating Trustee who is a retired senior Foreign Service Officer. The Cox Foundation is a tax exempt public foundation under sections 509(a)3 and 501(c)3 of the Internal Revenue Code, with its financial office in Texas.

The Trustees consult a Policy Council which includes retired and active duty senior Foreign Service Officers, and other distinguished individuals with experience in public service, international affairs, charitable foundations and education.

Biographies, in Order of Appearance

Ambassador **Charles A. Gillespie, Jr.** is a Principal with The Scowcroft Group and a Cox Foundation Trustee. A retired, 30-year career Foreign Service Officer, he was from 1985 to 1992 Ambassador to Colombia and then Chile and later served on the White House Staff as Special Assistant to the President and the National Security Council's Senior Director for Latin America and the Caribbean. In 1983, as Deputy Assistant Secretary of State for Inter-American Affairs, Ambassador Gillespie served concurrently as Ambassador and Chief of Mission to Granada while US military forces launched operations there. His overseas service includes Mexico, Nicaragua, the Philippines, Indonesia, and Belgium.

Kenton E. McDonald has been President of the Cox Foundation Board of Trustees since 2003. He lived in France from 1962 to 1964. He received a BBA with highest honors from Southern Methodist University in 1974, a J.D. from Southern Methodist University Law School in 1977, and joined Mr. Branscomb's law firm upon graduation. Mr. McDonald served on the Cox Foundation's Policy Council from 1994 until he became a Trustee of the Foundation in 1999.

Harvie Branscomb, Jr., Chair of the Cox Foundation Board of Trustees earned an AB from Duke University in 1943 and an LL.B. from Yale University Law School in 1948, after which he began the practice of tax law in Corpus Christi, Texas. As Mrs. Cox's attorney, Mr. Branscomb assisted Mrs. Cox in establishing the foundation that bears her name. He served as the Foundation's President from its inception in 1980 until 2003, when he became the Chair of the Trustees.

Ambassador **Maura Harty** became the Assistant Secretary for Consular Affairs in November 2001. Entering the Foreign Service in 1981, her overseas service includes Colombia, Spain, Lithuania, Mexico and Grenada, and Paraguay, where she was the ambassador. She served as Senior Watch Officer in the State Department's Operations Center, Special Assistant to the Secretary of State, Executive Assistant to Secretary of State, Managing Director of the Directorate of Overseas Citizens Services, and prior to assuming her present position served as the Executive Secretary of the Department of State. She received her BA from Georgetown University School of Foreign Service.

Royal D. Bisbee was the U.S. Vice Consul attached to Consulate General Bombay who assisted Una Chapman Dowd (later Cox) in 1948, the act that resulted in the Cox Foundation. Born in India of American missionary parents, he came to the United States in 1940. He served during WWII with the US Army Intelligence Service, working out of Baghdad. There he met and married Barbara Beeler, who was performing consular services at the U.S. Legation as a member of the U.S. Foreign Service Auxiliary. Mr. Bisbee entered the Foreign Service in 1947, arriving at Bombay, his first assignment in January 1948. Subsequent assignments were to Embassies New Delhi, Freetown and Manila, Consulates Thessaloniki and Lahore, and at the USIA, from which he retired in 1979. He has a BA from the University of Washington, MA from George Washington University, did in-service South Asian studies at the University of Pennsylvania and graduated from the National War College in 1964.

Ambassador **W. Robert Pearson** has served as Director General of the Foreign Service and Director of Human Resources since October 2003. Entering the Foreign Service in 1976, he has served in China, New Zealand, as Deputy Executive Secretary of the National Security Council, Executive Secretary of the Department of State, Chair of NATO's Political Committee and later Deputy Permanent Representative to the U.S. Mission to NATO and Deputy Chief of Mission of the U.S. Embassy to France. From 2000 to 2003 he was the Ambassador to Turkey. Ambassador Pearson graduated from the University of Virginia Law School after which he served with the US Navy Judge Advocate General's Corps.
